- 35 I warrant that
 - I am the owner of the specified motor vehicles and that each vehicle qualifies permanently, and not merely temporarily, under the exemption requirements for the selected registration period,
 - in the event of a basis of registration as per Numbers 1, 2a or 3 to 7, the specified purpose of the motor vehicle is clearly evident from the exterior,
 - in the event of a basis of registration as per Numbers 8-10, the vehicle is neither designed for commercial transportation of goods or own-account transport operations nor used for these purposes. The vehicle is neither intended for transportation of goods based on its design features (vehicle type and body type) nor is it used for transportation of goods within the meaning of §1 of the German Road Haulage Act (GüKG). The registration excludes use of the vehicle for commercial transportation of goods or own-account transport operations.
- 36 I am aware that
 - I myself am responsible for the factual and legal correctness of the information provided (self-declaration principle),
 - the registration is obtained for a maximum of two years and I am obligated to immediately notify Toll Collect of any changes (e.g. transfer or cancellation of vehicle registration) and if the exemption requirements for each vehicle cease to apply,
 - registration of the vehicles or vehicle combinations I have specified implies no legal recognition of toll exemption by Toll Collect or the German Federal Office for Goods Transport (BAG).
- 37 I am aware that
 - the competent authorities are at all times entitled to check the accuracy of the information I have provided
 - intentional or negligent non-payment or late payment of the toll is subject to a penalty of up to EUR 20,000. In addition, if fraud (§ 263 StGB) is proven, a custodial sentence of up to five years or a fine can be imposed, and the non-paid toll charges will be recovered
- 38 I hereby confirm that all the information I have provided is accurate and complete.
- 39 Toll Collect will only collect, process and use the data I have provided within the scope of this order for the purposes of registration for toll exemption. In addition, Toll Collect will send the data, including the separately submitted documents, to the Federal Office for Goods Transport (BAG). I consent to Toll Collect processing and using the data collected within the scope of this order. Furthermore, I consent to Toll Collect sending this data to the Federal Office for Goods Transport (BAG).

- 79** 8g. Self-propelled working machine or tractor operated exclusively in a vehicle combination with a working machine semitrailer.
